Stitching Together – more news from SEWN HQ:

Individual Client Level Data

Like many of our members, SEWN is very concerned at the new requirement on agencies that contract to MSD to provide it with identifying data about their clients. The SEWN Board says that it “strongly stands against the move by the Ministry of Social Development to oblige contracting NGO’s to provide the personal information of clients and their dependants.”

SEWN affiliates to Community Networks Aotearoa, which takes the voices of its regional and local network members to policymakers in Wellington. Here’s their message about work that they are part of:

Here at Community Networks Aotearoa we are aware that many of you are very concerned about the Individual Client Level Data clause being added by MSD to many contracts. We understand what your concerns are, and we share them. We want to let you all know what is happening here in Wellington.

A group of national organisations and head offices are working together to see if we are able to find a path forward with MSD. We understand their need for good data and the current Minister and Prime Minister’s directive to enable that data to be collected. We are offering to work together with the MSD staff, to find something that provides MSD with the data they need on service performance and results without affecting our trusting contract with our clients. To date this offer has not been responded to. We hope that everyone has sent in responses to the Privacy Commissioner’s investigation, and we will try to keep you up to date with the work happening here in Wellington, when and if we are able to share that. Please know that we have heard your concerns, and that on-going work is happening on this issue.

Nonprofit Sector Priorities for Election 2017

Yes, the PM has named the day. On Saturday 23 September our country will go to the polls to elect a new government. The lead-up to that will see lots of debate and competing claims from the candidates about what policies we need for social equity and community wellbeing. Our sector will also want to see policies for a thriving sector.

From now until the election, SEWN will be featuring the views of non-profit organisations about topics they would like to see on the election agenda. We would also love to hear from you about what your organisation sees as top priorities to get in front of candidates and political parties (sharon@sewn.org.nz or ph 366 2050). The more voices we have, the more chance we have to get our goals addressed.

We’re getting started with the challenges identified by the **Salvation Army** in its recently-released State of the Nation report, *Off the Track*, as discussed in this media release from the Salvation Army:

Off the Track

New Zealand has gone off track in key social areas and needs government to urgently address failing social policies, The Salvation Army says.

Its latest State of Nation report shows efforts to provide adequate housing, reduce child poverty and stop re-offending have gone off track and need effective policy approaches and action to address these issues.

The Salvation Army's tenth annual State of the Nation report highlights some areas of social wellbeing where little or no progress is being made. These include:

- An alarming lack of safe affordable housing, resulting in a level of homelessness not seen in New Zealand in the lifetime of most Kiwis
- A seemingly entrenched rate of child poverty
- Burgeoning incarceration rates of prisoners and the related high recidivism rates.

'In the past year Auckland experienced a 12-year high in new housing consents, but during the same time across the country the housing shortage got worse and housing became more unaffordable for people,' says Lt. Colonel Ian Hutson, Social Policy Director. 'This can't continue. Housing policy needs to provide a sufficient supply of affordable houses.'

Over the past five years various reports, warnings and commentary by child protection experts have outlined the disturbing realities of child poverty in New Zealand. Despite this information and Government promises of action the present rate of child poverty has not changed, says report author Alan Johnson.

'Entrenched child poverty has become the new norm. Politicians must stop just voicing sympathetic rhetoric and actually take real action to reduce child poverty numbers.'

The report also identifies that despite spending \$850 million dollars annually on running prisons and a plan to spend one billion dollars on new prisons, recidivism worsened in the past year.

'We are spending big on prisons, but failing to ensure that when people come out of prison they have work and a place to live, the two essentials in ensuring people don't reoffend,' Alan Johnson says.

The report does show that strong policies and leadership have had a positive impact on enrolments in Early Childhood Education, especially among our poorest communities.

Similarly, it acknowledges Government policy direction is having a positive impact in creating rising employment and growing GDP, plus reductions in youth offending and teenage pregnancies.

Hard questions remain though. 'In an election year, it is timely to challenge all who would aspire to govern—and, in fact, all New Zealanders — to think deeply about the social progress we want to achieve for ourselves and our children,' says Ian Hutson.

The Prison Gate: A Revolving Door or a Second Chance?

A new Salvation Army report says changes must be made to how prisoners re-enter society for New Zealanders to feel safe and secure in their homes and communities. The latest report by The Salvation Army's Social Policy and Parliamentary Unit *Beyond the Prison Gate: Reoffending and Reintegration in Aotearoa New Zealand*, argues the system is failing prisoners and the public.

"The prison gate has for too long been a revolving door rather than a transition into a second chance at life. Instead of being effectively rehabilitated and reintegrated into society, many prisoners on release become 'repeat customers'," says report author Annaliese Johnston. The cost of prisons is spiralling out of control and doing nothing to reduce reoffending, while refocusing efforts on effective alternatives and reintegration would save the country millions, reduce crime and make the country safer, she says.

The report also looks at the experiences of past inmates for a first-hand look at how the system impacts those who have been released and how things might be improved. Despite crime rates falling overall, the prison population has tripled since 1985 and is likely to reach a record 10,000 people next year. Corrections is also unlikely to meet its composite target of reducing reoffending by 25 per cent by 2017. Post-prison reoffending rates have barely changed in the past 10 years. Instead the report recommends reducing spending on custodial prison sentences and moving investment to programmes that will reduce crime and support reintegration for the around 15,000 people released from prison in New Zealand each year. Recommendations include better access to accommodation and health services, private-public partnerships to provide employment, and mentors.

'If we are not sufficiently supporting people to reintegrate then they are much more likely to re-offend. That is not good for anyone, and so far our current approach is failing to make meaningful progress. We know that there are alternative approaches, such as the justice re-investment model, that improve community safety and make better use of public money' Johnston says. 'As one of our research participants put it, "instead of the Government spending over 90 grand to keep us in prison every year, why don't they invest it on keeping us out?"'

The report was launched on 7 December at St Andrew's on the Terrace in Wellington.

Giving Together has Exponential Effects on Communities

Philanthropy used to imply a flashy name and a big cheque. Today philanthropy involves many cheques and many donors committed to working together to change lives and communities. Collective giving or *giving circles*, as they are known, have been quietly at work for decades. Now, they are front and centre in the world of philanthropy as a movement that continues to gain in popularity, strength and results.

Collective giving is a form of grant-making that involves learning, decision making and community building together – activities that particularly appeal to women donors. Participants who are part of a collective giving grant-making organization, or giving circle, aren't as likely to simply give a cheque and move on. They are engaged for the longer term. They want to learn about the needs of their community, read letters of inquiry from non-profits, go on site visits, do due diligence on prospective grantees and ultimately vote democratically on which non-profits receive grants. Moreover, they tend to not only stay involved in their organisation, but often become donors, volunteers or board members of an organisation that they encountered through the vetting process.

New research shows that these collective giving networks are growing both in dollars and number of donors and this growth is changing the landscape of giving. Research from 2009 found about 600 giving circles in the United States. But recent research by Angela M. Eikenberry, Professor of Public Administration at the University of Nebraska Omaha, and colleagues, found a dramatic increase in this form of philanthropy. Today there are at least 1,314 giving circles with more than 46,000 members who have collectively contributed more than \$474 million over the past 30 plus years. The study, [The Impact of Giving](#)

shows that participation in giving circles deepens engagement and ultimately expands individual and household giving, providing a basis for future philanthropy.

Giving circles usually operate individually within their own communities. More recently, however, like-minded groups have organized broader collective giving networks to amplify their voices, share ideas, and learn from each other. For example, Darryl Lester founded the [Community Investment Network](#) in 2006 to encourage African Americans and communities of colour to work collectively to create the changes they wished to see. Today, with more than 250 members in the network, CIN affiliates have awarded \$250,000 in grants and contributed more than 14,000 volunteer hours in their communities.

[Impact 100](#) is one example of a giving circle. Started in 2001 in Cincinnati, OH, there are now more than 30 Impact 100 groups operating in the United States, 6 in Australia, and 14 in development. The [Impact 100 Pensacola Bay Area](#) organisation has invested more than \$7 million in non-profits in the area since 2004 including more than \$1 million in 2016 alone, much of which came from new donors.

The world needs more philanthropy of all kinds to make the change we all want to see. Giving circles are evidence that local groups of thoughtful, committed citizens can indeed change the world. As Margaret Mead said, "It's the only thing that ever has."

Child sponsorship dwindling

A survey has found New Zealanders' donations to non-government organisations and charities has fallen 15 percent in the past 10 years. The report - by umbrella agency the Council for International Development - showed charities and NGOs operating in New Zealand took 56 percent of their \$182 million funding in 2015 from the public. However, financial support from the public dropped to \$102.4 million in 2015, from about \$120 million in 2005. While New Zealanders were more engaged in global disaster situations, sponsorships of children - which accounted for 40 percent of revenue for the measured organisations - had fallen for the fourth consecutive year.

CID director Josie Pagani said the fall in revenues was not because the public had lost faith in NGOs, but because people were becoming more likely to give money directly to causes, or through other methods like Givealittle. The organisations were developing new public funding strategies, Ms Pagani said.

"Rather than a message which says we'll take your dollar and 80 cents of that will get to the field and 20 cents will help us run our organisation - and that's still absolutely true, NGOs need an operating budget - but it's almost like they're looking at a model where they're saying, 'We'll invest it for you, we'll take your dollar and turn it into \$1.60'".

The report also showed that more than two-thirds of the organisations that responded to the survey had a private sector partner, up from one-third the previous year. International NGOs were collaborating more, with 63 percent working with another NGO.

The report noted that the Ministry of Foreign Affairs and Trade was turning its funding attention more specifically toward the Pacific region.

Strategy Celebrates Christchurch's Diversity

A new strategy has been adopted to embrace Christchurch's status as a diverse and multicultural city. [The Christchurch Multicultural Strategy 2017-2021 "Our Future Together"](#) was adopted by the Christchurch City Council at a meeting 9th February 2017.

In June 2015 the Community Housing and Economic Development Committee resolved to establish a Multicultural Working Party to produce a strategy. The document will help the Council respond to the changing face of the city's population. It sets a number of goals and actions that will help all residents feel they belong and are welcome here.

New Pilot Programme for Social Housing Tenants underway

A new pilot programme is underway to help at-risk social housing tenants hold onto their tenancies, Social Housing Minister Amy Adams said today. Under the Sustaining Tenancies Initiative, tenants with complex or serious needs who may be at risk of losing their tenancy will receive practical support from community providers to help get back on track.

"We know that steady housing helps provide stability and security, however, some tenants face eviction from their home for anti-social behaviour or financial issues, only to end up in need for emergency housing. If we can avoid them being evicted by resolving their behaviour, this benefits the tenant, their family, and the taxpayer," Ms Adams says.

"We want to try new ways of supporting people who live in social housing with these issues. Through a social investment lens, the Sustaining Tenancies Initiative aims to address the underlying causes of eviction, leading to better outcomes."

When the initiative is fully up and running, eight community providers will work alongside around 1000 vulnerable social housing tenants, with funding of \$5 million over two years. From today, the first three providers in the initiative are underway. These are:

Affinity Services (Auckland) Downtown Community Ministry (Wellington) Comcare Trust (Christchurch).

"Many tenants would like to address the causes of their behaviour but don't know where to turn. Under this new initiative, practical support is available," Ms Adams says. "The kinds of practical support available will depend on what each tenant needs, but could include budgeting advice, help with relationship issues, healthy living plans, life skills coaching, and assistance to help tenants return to education, training or to find stable work."

This initiative is part of the \$9 million Better Housing Outcomes package, announced in July 2016, to improve the supply of housing for vulnerable people and to help people stabilise their tenancies.

Community In Mind - Shared Programme of Action

The Greater Christchurch Psychosocial Committee and Greater Christchurch Psychosocial Governance Group provide leadership and governance for psychosocial recovery and wellbeing work. The Psychosocial Committee began operating in September 2010 to carry out Civil Defence functions, co-chaired by the Ministry of Social Development and the Canterbury District Health Board.

After the instatement of CERA in early 2011, the Committee operated as a sub-committee of the CERAlled Community Wellbeing Planners Group. As a part of CERA's disestablishment, the sub-committee evolved into the Greater Christchurch Psychosocial Committee.

CERA worked with the Psychosocial Committee to develop the Community in Mind Strategy (released June 2014) and Shared Programme of Action (released May 2015). CDHB-CPH inherited responsibility for the Shared Programme of Action at the beginning of 2016.

The Psychosocial Committee uses the Shared Programme in conjunction with other forms of monitoring to plan, coordinate, promote and monitor the psychosocial recovery and wellbeing of the population of greater Christchurch. A comprehensive review of the Shared Programme was initiated during 2016 to ensure the work to maintain the Shared Programme was well-integrated at Community and Public Health, with a full sense of ownership from the Psychosocial Committee. Police Vetting

The positive announcement by Government of explicit exemptions now being provided for the voluntary sector in the Policing (Cost Recovery) Amendment Bill, means that registered charities and agencies making 20 police vetting requests or fewer per year will be exempt from fees. The earlier proposal was for fees across the board to be the same, i.e. for profits and not-for-profit organisations. Thanks to our sector's national bodies and all others who lobbied for this.
